## A. Assessment Criteria

3. Correctness of grammar, format and citations (including footnotes)	20

## B. Mark Reduction

- Memorials with length exceeding 4000 words shall be subject to mark deduction according to the scale as stated under Rule 7.
- Late submission shall be subject to deduction of 5 marks for each calendar day on each memorial beyond deadline.

#### B. Mark Reduction

Each team member shall **refrain from disclosing the name of his or her institution**. Disclosure may subject the mooters concerned to a **deduction mark of 5 points** from their individual score, which will in turn affect the team's overall score. The judge identifies the violation should mark on the score sheets. The Chief Judge will play a facilitating role to align on decision within the panel of judges in the courtroom to validate the mark deduction.
